



SEVEN WEST MEDIA COOKIES GUIDE (Updated April, 2019)

Introduction

To make our websites work properly, and to provide you with the most relevant products and services when you visit our websites, we place small data files called cookies on your device. We use device IDs for the same purposes when you use our IOS, Android and Connected TV applications. This guide provides you with information about cookies and how to control them for our websites, and about device IDs and how to control them for our and mobile and Connected TV applications.

A. What is a Cookie?

A cookie is a small text file that a website saves on your computer or mobile device when you visit the website. Cookies are then sent back to the originating website on each subsequent visit, or to another website that recognizes that cookie, to develop a record of your online activity. Cookies on the Group's websites may be delivered in a first-party (set by the relevant Seven West Media (SWM) website) or third-party (set by another website) context and may also be set in association with emails you receive from us.

Cookies help us:

- remember information about you so you don't have to give it to us multiple times;
- keep you persistently signed in across different devices;
- understand how people are using our services, so we can make them better for you; and
- personalise your experience across our products and services by remembering what you like, your preferences and settings. For example, you can pause and pick up where you left off watching a show, across different devices

and all this helps us enhance your experience when using one of our websites.

B. Types of Cookies we use on our websites

We use different types of Cookies on our websites:

1. **Essential Cookies.** These cookies are essential for enabling your movement around our websites and providing access to features such as your profile and purchases, member-only resources, and other secure areas of the website. These cookies do not gather information about you that could be used for marketing purposes and do not remember where you have been on the internet. This category of cookies cannot be disabled.

- 2. Analytics Cookies.** We use analytics cookies to collect information about how visitors use our website and where visitors have come from. These cookies collect information in the aggregate to give us insight into how our websites are being used, in order to gather audience ratings and anonymous viewing data. Analytics cookies are used by our analytics and measurement services providers including Google Analytics, Nielsen, OzTAM and Chartbeat.

For example, we anonymize IP addresses in Google Analytics, and the anonymized data is transmitted to and stored by Google on servers in the United States. Google may also transfer this information to third parties where required to do so by law, or where such third parties process the information on Google's behalf. Google will not associate your IP address with any other data held by Google.

- 3. Advertising Cookies.** Advertising cookies are used to measure the effectiveness of our advertising campaigns and to provide you with advertising you are more likely to be interested in. We use a data management platform (“DMP”), and our DMP deploys a cookie when you interact with an advertisement on one of our websites. This cookie collects personal information such as which pages you visit on the website, your history arriving at the website and your purchases from us. Collected information is used to evaluate if advertisements have been read and you find them useful, the effectiveness of our advertising campaigns or to provide better targeted advertising in future.

Various ad network companies serve advertising to you when you visit our websites, including Google, Telaria, Rubicon, AOL, Appnexus, Index Exchange and Outbrain. Using cookies, they may collect information about your browsing behaviour on our websites and other websites outside the Group to determine what advertisements are delivered to you across our websites and other websites outside the Group.

- 4. Product Cookies.** Product cookies are used for personalisation, such as to provide you with content and recommendations regarding content you are more likely to be interested in, or to remember your settings. Our service providers may deploy a cookie when you interact with a product on our website (for example a particular program).



This cookie also collects personal information such as which pages you visit on our website, your history arriving at our website and what content you have watched. Collected information is used to evaluate if particular programming has been viewed by you, so that we can recommend and provide you with access to content we think you will like in the future.

Third Party Websites' Cookies

When using our websites, you may be directed to other websites for such activities as surveys, to make payments etc. You may also have access to our content on other websites from time to time. These websites may use their own cookies. We do not have control over the placement of cookies by other websites you visit, even if you are directed to them from our website.

C. How to Control and Delete Cookies

If you do not wish for data to be collected through the use of Cookies on the Group's websites, you can disable, remove or block the use of Cookies in your internet browser. To disable cookies through your browser, follow the instructions usually located within the "Help," "Tools" or "Edit" menus in your browser. Please note that disabling a cookie or category of cookies does not delete the cookie from your browser unless manually completed through your browser function.

Essential Cookies

Essential cookies cannot be disabled.

Analytics Cookies

Collection of your data from our analytics cookies can be deleted. If cookies are deleted, the information collected prior to the preference change may still be used, however, we will stop using the disabled cookie to collect any further information from your user experience.

Note when you opt out of tracking, a new cookie may be placed to prevent you from being tracked.

Also, even after you have opted out of use of your data by these companies for online behavioural advertising/ interest-based advertising, these companies may still collect your data for other purposes such as analytics and research. Also you will still receive ads, but these ads may be less relevant to your interests. Also note that you may need to repeat the steps above if you use a different device or delete browser Cookies.

D. Device IDs used on our mobile applications and Connected TVs

In IOS and Android mobile applications as well as Connected TVs, device IDs (IDSA) and Ad IDs (instead of cookies) are used to perform the functions described in Part A and Part B.

E. Controlling device IDs used on our mobile applications and Connected TV applications

To opt-out of “online behavioural advertising” or “interest-based advertising” on the Group’s mobile applications and Connected TV applications, you can modify the settings on your mobile device. Depending on your device, this may be as simple as:

- For iOS devices, go to Settings, select Privacy, select Advertising, and enable the “Limit Ad Tracking” setting;
- For android devices, open the Google Settings App, select Ads, and enable the “Opt out of interest-based advertising” setting.
- For Telstra TV devices, go to Settings, select Privacy, select Advertising, and enable the “Limit Ad Tracking” setting. You can also clear your data by resetting the advertising identifier on Telstra TV;
- For Apple TV devices, go to Settings, select General, select Privacy, and enable the “Limit Ad Tracking” setting. You can also clear your data by resetting the advertising identifier on Apple TV;
- For other devices, please see our FAQs. Where ad tracking is not able to be limited on a particular device, we do not use the device ID for ad personalisation.
